This important Environmental Impact Assessment (EIA) appeared on the website of the Burma Rivers Network – http://www.burmariversnetwork.org/ in July 2011. The full report (945 pages) was rather large and may be inaccessible to many users. It was also in a pdf format which prevented copying text, which is also a problem for some people. The Online Burma/Myanmar Library (OBL) reduced the size of the document using the Adobe pdf writer "reduce file" function and is in the process of passing the files through Finereader, an optical character recognition (OCR) programme, and the Adobe "scan to pdf" function in order to convert them to a format which allows copying of text. We have not yet converted the appendices, but since this hydropower project is currently being discussed in and outside Burma, we are issuing the work in progress and will upload the remaining conversions when completed. N. B. the converted format is less crisp than the original, and the maps and charts may be less legible.

The report contains 3 parts and 3 appendices.
