

**THE CITY OF YANGON MUNICIPAL (AMENDMENT)
ACT, 1959.***

[Act. No. XLIV OF 1959]
(The 29th September 1959)

It is hereby enacted as follows: —

1. (1) This Act may be called the City of Yangon Municipal (Amendment) Act, 1959.

(2) It shall come into force on the 1st October 1959.

2. Section 5 of the City of Yangon Municipal Act hereinafter referred to as the said Act *shall be deleted*.

3. In section 19 of the said Act, the words “the Education Board or”, and the words “Board or” *shall be deleted*.

4. In section 20 of the said Act, the words “of the Education Board or”, the words, “or of the Education Board” and the words “or Education Board” *shall be deleted*.

5. In section 21 of the said Act, the words “or of the Education Board” and the words “ Board or” *shall be deleted*.

6. In section 22 of the said Act, the words “or of the Education Board” *shall be deleted*.

7. In section 23 of the said Act, the words “of the Education Board or” and the words “or of such board” *shall be deleted*.

8. In clause (a) of section 24 of the said Act, the words “or of the Education Board” *shall be deleted*.

9. In section 25 of the said Act —
 (a) *after the semi-colon (;) at the end of clause (xxviii) the word “and” shall be inserted; and*
 (b) *clause (xxix) shall be deleted.*
10. In clause (ii) of section 26 of the said Act—
 (a) *the words “schools or” shall be deleted; and*
 (b) *sub - clauses (a) and (b) shall be deleted.*
11. In clause (b) of sub-section (1) of section 38 of the said Act, the words “or Education” *shall be deleted.*
12. Section 63 of the said Act *shall be deleted.*
13. In Section 64 of the said Act, the words “or of the Education Fund” and the words “or the account of the Education Fund of the City of Yangon,” as the case may be *shall be deleted.*
14. In section 65 of the said Act, the words “or, out of the Education Fund” *shall be deleted.*
15. In section 68 of the said Act, the words “or, of the Education Board” *shall be deleted.*
16. In section 69 of the said Act, the words “and Education Fund” *shall be deleted* and for the words “of each fund,” the words “of the fund” *shall be substituted.*
17. Sub-section (2) of section 70 of the said Act *shall be deleted.*
18. In section 71 of the said Act —
 (a) *in sub-section (1), for the words “Municipal and Education Funds,” the words “Municipal Fund” shall be substituted.*
 (b) *in sub-section (2), clause (c) shall be deleted.*
19. Section 76 of the said Act *shall be deleted.*

20. In section 203 of the said Act, the words "or the Education Board" *shall be deleted.*

21. In section 224 of the said Act, the words "or of the Education Board" *shall be deleted.*

22. In section 235 of the said Act —

(a) in clause (iii) —

(i) in sub - clause (a), the words "Education Board and" *shall be deleted.*

(ii) in sub-clause (b) and (c), the words "board and" wherever they occur *shall be deleted.*

(iii) in sub-clause (d), the words "of such board or" *shall be deleted.*

(b) in clause (iv) —

(i) in sub- clauses (a) and (c), the words "the Education Board" wherever they occur *shall be deleted.*

(ii) in sub-clauses (d) and (e), the words "the Education Board or" wherever they occur *shall be deleted.*

(iii) in sub-clause (g), the words "or member of the Education Board" *shall be deleted.*

(iv) in sub-clause (h), the words "Education Board" *shall be deleted.*

(c) in clause (xi), for sub-clause (a), the following *shall be substituted* as sub-clause (a); *namely: —*

"(a) the manner in which and the person by whom payments may be made out of the Municipal Fund or cheques drawn upon the said fund may be signed:"
