Amid fear and speculation of more turbulence during the dry season, life in the Karen refugee camps seems to go by quietly as the refugees struggle from day to day in order to survive and they have come safely to the end of yet another summer month. It is sad to note however that, unfortunately, life had not been so calm or uneventful for everybody.

Schools are now closed for the summer holidays and will reopen in June.

Scarcity of water is a big problem in the camps now as is usual each year during the peak of summer. Efforts are made by all those concerned to help solve the problem.

The rainy season is not too far away now and this is the time when people in the camps are busy with repairing and putting new roofs on their houses. It came as a tragic blow when about midnight on March 30, a fire broke out in the outer sector of the market place adjacent to Wang Ka camp. In less than an hour, more than a hundred shops and houses in the area were razed to the ground before the fire could be brought under control. Many houses in section 8 of Wang Ka camp which is adjacent to the market place but in another direction were affected by the fire.

The Karen Refugee Committee expresses its sincere gratitude to the Thai authorities and to the people of the Kingdom of Thailand for the kindness and understanding they have shown in granting refuge to the Karens and to other displaced people from Burma who are in trouble and need. The committee is fully aware of the fact that, unless for the kindness and understanding manifested in the name of humanity, the refugees would not be able to survive. This noble gesture of goodwill is sincerely appreciated and will always be remembered .

The Karen Refugee Committee also expresses its sincere gratitude to the individuals and agencies concerned, for their help and support in many ways and through the years to provide the refugees with those basic items of need. The commitment of all those involved in this mission of mercy is sincerely appreciated and will also be remembered by all of us .

The situation has again become relatively quiet for the moment but people are still living in an unpredictable state. The refugees greet the new year with a feeling of fear and uncertainty but deep in their hearts still flickers a faint ray of hope for better days. They long for peace, genuine and honourable peace to come back to their greatly troubled land. They count on the help and support of all peace loving people around the world.

The Karen Refugee Committee reiterates its firm belief that it is in the best interests of the refugees that they should ultimately return to Burma. It believes however that return must be voluntary and to a situation of safety. It is disturbing to note however that Karen civilians in many parts of Burma continue to go through very difficult and perilous times.

The committee believes that in order to allow for the safe voluntary return of refugees to Burma, effective monitoring by an appropriate independent monitoring body should be regarded as the necessary prerequisite.

Until and unless such an independent monitoring body can say in all certainty that it is safe for the refugees to go back, the Karen Refugee Committee humbly appeals to the Royal Thai Government, to the people of the Kingdom of Thailand and to the international community to continue granting permission for these refugees to remain in the Karen refugee camps in Thailand.
