

Update:

FOREIGN INVESTMENTS

The "*BURMA ALERT*" has been monitoring foreign investments and trade with Burma since January 1990. The following is a compilation of all the foreign companies reported in the "*ALERT*" since that date. Providing information on Burma is a hazardous business since the ruling military junta, the State Law and Order Restoration Council (SLORC), does not believe in the freedom of information. Records available to the general public are scarce. For the most part, we have relied on news items published for propaganda purposes in the official Working People's Daily/New Light of Myanmar. As such, some of the investments reported are over-stated. Many represent intent to invest rather than actual investments. Where possible, we have tried to verify the actual amounts invested. All investments are in US dollars. Some companies have, under pressure, announced their withdrawal from Burma but still maintain an office in Rangoon. We have dropped companies from the list only when we have been able to verify that they have actually withdrawn. We have not attempted to separate investments from trade since the two are often linked. Classifying investments by country is also a tricky business since modern corporations are cross-linked and operate across international borders. Thai timber companies are particularly difficult to track since most are small. Only those with new timber concessions are listed. Dates given are dates when companies were first reported in the media. They could have invested or been operating in Burma earlier. To the best of our ability, we have tried to provide an accurate picture of foreign investments and trade with Burma. However, given the paucity of information, mistakes are inevitable. We, therefore, request our readers to send in any corrections.

(Burma's) economy desperately needs foreign aid and investment to bloom... (SLORC) has approved foreign-investment projects worth \$3 billion since it decided to open up the country, and the influx of capital has helped get the economy moving again.... Foreign investment is growing... (But) foreign investment figures are deceptive. SLORC never speaks about the amounts actually invested and promised.... With a currency that has a fixed rate of approximately Kyat 6 to US\$1 and a blackmarket value of approximately 110 to 1 and with inflation a constant, the kyat has no real value; with Burma's international debt estimated at US\$5.5 billion, its debt service obligation at approximately US\$1 billion and its foreign exchange reserves reported at a half billion, Burma is not in a position to allow a free market to exist. Also, with Burma's inability to borrow money from the World Bank and other international institutions, it cannot raise funds in large amounts through normal banking channels and thereby is limited in its ability to stabilize the currency.... It also is limited in making investments on long-term infrastructure projects such as power plants, water projects, roads and commercial transportation.... According to the ADB Annual Outlook (April 1995) industrial growth slowed in 1994; an IMF report in November 1994 indicated a continuous decline in foreign investment from 1990 to 1993; more important, it found a shift from capital to consumer goods in imports and this is reflected by the growing number of hotels, karaoke bars and department stores.... suggesting little or no growth in secondary industries.... Given this pattern, Burma resources are not fueling industrialization and long term growth.... the backing of small friendly nations and tourism will not be enough to overcome the problem.
