# CANADA RECEIVES DR SEIN WIN

Acting Prime Minister Sheila Copps met with Prime Minister Dr Sein Win of the National Coalition Government of the Union of Burma on 9 June and re-affirmed Canada's support for the Burmese democracy movement. Dr Sein Win was introduced to the House of Commons by the Speaker and met with Secretary of State for Foreign Affairs (Asia-Pacific) Raymond Chan on 7 June. He assured Dr Sein Win that Canada had no intention of encouraging trade with the State Law and Order Restoration Council (SLORC) regime in Rangoon. Sein Win also testified before the Joint Senate-House Foreign Affairs Committee and the Parliamentary Standing Committee on Human Rights and the Disabled. The Prime Minister stressed that the human rights situation in Burma has worsened in ethnic areas in spite of the much-publicized cease-fire negotiations between the ethnic groups and the Burmese He said that 1994 is a critical year for Burma as SLORC could begin to make real political concessions if international pressure is maintained. Otherwise, he said, SLORC will consolidate its hold on power by only making superficial reforms. Dr Sein Win called for crossborder humanitarian assistance for the 800,000 internal refugees displaced by SLORC's forced relocation and slave labour campaigns, and more concrete political and financial assistance to the Burmese democracy movement. Prime Minister was in Canada from 5-11 June at the invitation of the International Centre for Human Rights and Democratic Development (ICHRDD). Dr Sein Win met with the leaders of Canadian political parties, a number of Members of Parliament, Bob White, President of the Canadian Labour Congress and spoke at the Law Faculty of the University of Ottawa on 9 June. He also met with non-government organizations in Ottawa hosted by the Canadian Council of International Cooperation and in Toronto hosted by the Canada-Asia Working Group, as well as with Burmese communities in Toronto, Ottawa and Montreal. Prime Minister addressed the Board of Directors of the ICHRDD in Montreal on 11 June, before returning to Washington, DC. He was accompanied in Canada by Bushan Gulati, Committee for the Restoration of Democracy in Burma (Canada), and Harn Yawnghwe, ADDB.

# **BACTERIOLOGICAL WARFARE?**

The Karen Human Rights Group has suggested that SLORC may be using bacteriological warfare against the Karen and Mons. As early as Aug.93, Karen villagers in Thaton and Mudraw districts reported SLORC aircraft dropping by parachute mysterious white boxes with balloons attached. Between 3-14 days later, villagers in the drop area and downstream experienced severe diarhoea resulting in death. In September 1993 alone, 185 died in one area. In Jan.94, SLORC aircraft reportedly sprayed yellow powder over the headquarters area of the New Mon State Party. The bacteriological warfare claim has not been verified.

# SHAN FIGHTING INTENSIFIES

During the months of May and June, SLORC stepped up its military campaign against Khun Sa's Merng Tai Army. On 26 May, the MTA blew up the dyke of a reservoir to cut off water supplies to Tachilek. As a result of the fighting, more refugees have crossed the border from the Shan State to Thailand [BWR940603].

# U WIN KHET VISITS EUROPE

U Win Khet, Chairman, National League for Democracy (Liberated Area), visited Norway 30 May - 13 June in his capacity as Chairman of the Democratic Voice of Burma Radio in Oslo. He established party-to-party ties with the ruling Norwegian Labour Party, met with Members of Parliament, and with the Norwegian Solidarity Committee of Trade Unions. U Win Khet then visited London 13-30 June at the invitation of the Burma Action Group. He met with Luis Ayala, Secretary-General of the Socialist International to renew fraternal ties briefed officials from the British Foreign and Commonwealth Office [NLD-LA940615].

# CUBAN FM IN RANGOON

From 12-14 Mar, Cuban Foreign Minister Roberto Robaina Gonzales made an official visit to Rangoon after visiting Indonesia and Laos. # SLORC DELEGATE ESCAPES TO LIBERATED AREA

Daniel Aung, a delegate and a presidium member of SLORC's National Convention escaped to the liberated area of Burma on 1 May 1994. At the press conference in Manerplaw on 26 May 1994, Daniel Aung said that he fled because he had lost faith in the National Convention. He said that delegates had to follow guidelines set by SLORC and that suggestions from delegates are not taken seriously. He claims that many restrictions are being placed on the normal activities of political parties with the aim of gradually eliminating He said that political party branches at the township level are being arbitrarily disbanded by SLORC on the grounds that the party has insufficient members. Daniel Aung also alleged that state funds are being used to build up the Union Solidarity and Development Association (USDA) which is supposed to be a civic organization. People are being coerced to join USDA mass rallies and, in his opinion, the USDA will replace General Ne Win's discredited Burmese Socialist Programme Party. Aung is a Lahu National Development Party people's representative elected on 27 May 1990 from Mong Ping, Shan State [NCUB].

# USDA MASS RALLIES

The USDA held numerous mass rallies in Burma in 1994. As claimed by Daniel Aung, most observers see the USDA being developed by SLORC to replace the BSPP along the lines of Indonesia's Golkar Party. The following are edited transcripts of letters written about the mass rallies to the British Broadcasting Corporation and broadcasted on 21 Feb.94. The transcripts were circulated by the Karen Human Rights Group on 7 March 1994:

"In our city of Mandalay, SLORC announced through loud speakers that anyone who did not participate in the rally would have their water and electricity cut off and fined Kyat 100 each. So 90% of the people did not dare to disobey their command."

"In our town of Prome, people were brought into a compound at 9 pm on the night before the rally. After sitting for several hours on the sandy ground, which had been sprayed with water, some people asked for permission to answer the call of nature outside the compound. Permission was denied by the security forces and a scuffle Many tried to climb the bamboo broke out. fences and were beaten with sticks and bamboo canes by the guards. In the ensuing confusion, men, women and children were trampled by the crowd. Two men died, two women broke their backs, and twenty people were wounded. This information was never reported on Myanmar Radio. Why? I am writing this letter to the BBC to let everyone know the true story of the Union Solidarity Development Association."

A civil servant

(The rally was on 7 February 1994. Several thousand people were held in the compound).

"The reports on the BBC Burmese program of 13 February about the rallies organized by the Union Solidarity Development Association are correct. In northern Shan State, a USDA rally was held on Friday 21 January. The number of people participating in the rally did not exceed 10,000 but Myanmar Radio announced that 210,000 people attended the rally. As for the students, their teachers warned them that each and everyone of them must attend the rally or else receive 15 lashes of the cane. They had to provide their own lunch. Government workers were told that they should know what the consequences would be (dismissal) should they fail to attend the rally. The entire population of Burma is against this kind of rotten tactic employed by SLORC. SLORC may be able to gather people together but they can never gain their respect or sympathy."

"I want to tell you that SLORC is lying to the people about the Union Solidarity Development Association. They announced that over 100,000 people came from various townships, divisions and states to support the USDA at mass rallies. This is a lie. For over 30 years now the military junta has been oppressing civilians like this, forcing them to join mass rallies. They always force everyone, young or old, and students and workers too."

# THAILAND:

DINERS CLUB (THAILAND) and CITIBANK BANGKOK launched Diners Club in Burma on 17 Feb.94. American Express, Visa and Mastercard are accepted in Burma [WPD940218].

The PETROLEUM AUTHORITY OF THAILAND (PTT) which is purchasing natural gas from the Gulf of Martaban has a 35% share in PETRO-ASIA. Its partners are CHAROEN POKPHAND (35%) and China's state oil firm SINOPAC Petro-Asia will operate oil refineries, distribute and sell oil products in the Asia Pacific region including Bangladesh, BURMA, Cambodia, China, Laos, the Philippines, Thailand and Vietnam. Petro-Asia International chairman Dr Thongchat Hongladarom said that Petro-Asia is setting up a retail oil business in Canton, Maoming, Shanghai, Tian Tsin and Dalian in China. Petro-Asia (Saigon) will operate a US\$28 million oil business in Vietnam and Petro-Asia (Thailand) will open its first service station on the Bang Na-Trat Highway. Petro-Asia location will have a 7-Eleven outlet, Kentucky Fried Chicken, Chester Grill and the CP restaurant chain Inter-Suki [BWR940513].

# SINGAPORE:

APPLIED INVESTMENTS and the Directorate of Hotels & Tourism formed a US\$0.6 million joint venture to provide tourist services [F940609]. Allied Investments also owns MYANMAR-SWAN INVESTMENTS which is renovating the MANDALAY HOTEL (BA No.3, Vol.5, Mar.94).

SSL which is also building a five-star hotel in Rangoon, is part of KEPPEL CORP [A940525, WPD940329].

# **MATTERS FOR CONCERN**

#### **BURMESE LABOUR NOTES**

On 1 May, Maung Maung, FTUB, addressed a crowd of 10,000 people at the May Day rally of the Aarhus Social Democrat Party and the Aarhus Trade Union Congress in Denmark. He also met with labour organizations in Denmark and Norway before leaving for Switzerland in June to attend the International Labour Organization Conference in Geneva.

# BURMESE PROTEST IN NORWAY

On the 4th anniversry of the 27 May 1990 general elections, the Oslo-based Burma Support group and Burmese students demonstrated in front of the Thai Embassy. They chanted, "Thailand out of Burma" and "Thai business is Burmese death," to protest Thailand's growing support for SLORC. A letter which stated, "It is with regret that the Norwegian people are learning that the authorities of Thailand have adopted such a hostile attitude towards the forces that are trying to achieve freedom and peace for the people of Burma," was handed to the Thai Minister Counsellor. SLORC does not have an embassy in Norway.

#### PROTEST IN RANGOON

On 27 May 94, Thierry Grandidier, 25, a Swiss-French national, stood outside the Sule Pagoda in downtown Rangoon and unfurled a banner that said "Release Aung San Suu Kyi." A curious crowd of more than 100 gathered around for about 15 minutes before undercover military intelligence agents snatched the banner from him. Thierry then started to walked towards the US embassy. The crowd followed him to protect him until soldiers intervened and arrested 7 onlookers and took them away in a truck. Thierry was not arrested and was able to get on the first available plane out. A military intelligence agent boarded the plane,

took Thierry's photograph and handed him the following note: "To Thierry Granditiers, Seat No.(). We know who you are, where you come from. We know what you have done, where you have gone, and where you have contacted. But we don't want to arrest you because you are not worthing even one cent. Good-bye you mother \$\$\$\$\$\$."

# BURMESE IN INDIA PROTEST AT THAI & SLORC EMBASSIES

On 27 May, Burmese students and youth protested in front of the Thai and SLORC embassies in New Delhi. A letter to Thai Prime Chuan Leekpai protesting the invitation of SLORC to ASEAN was handed over.

# DRUMS FOR FREEDOM

The French-language section of Amnesty International in Canada held a drum rally at Parc du Mont-Royal in Montreal on 29 May 1994 to mark the 4th anniversary of the elections in which Daw Aung San Suu Kyi's National League for Democracy won over 80% of the parliamentary seats. The drummers at the rally dedicated their efforts to the Pyidaungsu Drum Band, whose members were arrested on 5 May 1990 for supporting the NLD.

# 8888 FORCES-NMSP MEETING

From 10-20 May, a delegation of 8888 Forces, met with New Mon State Party Chairman Nai Shwe Kyin and party leaders to discuss the current political situation. The delegation included Justice Minister U Thein Oo, Health and Education Minister Dr San Aung, NLD (LA) COC Member, U Than Htut, Chairman U Myint Zaw of the Democratic Party for New Society, Secretary 1 U Aung Htoo and CEC Member U Aung Naing Oo of the ABSDF.

#### SELECTIVE PURCHASING

In May 94, State Representative Byron Rushing introduced legislation that will prohibit the State of Massachusetts from awarding contracts for goods and services to companies doing business with or in Burma. #### International Action:

# **OSLO BURMA FORUM**

As a follow up to the Oslo Donors Meeting held in September 1993, the ADDB and the Norwegian Burma Council organized a Burma Forum for interested NGOs in Oslo 30-31 May 1994. The Forum discussed the rapidly changing political situation and explored the feasibility of international NGOs operating in Burma. The Forum concluded that it was still too early to promote such a move and recommended that NGOs consider cross-border projects.

#### **BURMA DONORS SECRETARIAT**

A meeting of donor agencies following the Oslo Burma Forum, established a BURMA DONORS SECRETARIAT to coordinate projects and assist groups in Burma to obtain increased funding. The Secretariat is not a funding nor an implementing agency. # **BURMESE MOTHERS DAY**

On Daw Aung San Suu Kyi's 49th Birthday, the Australia Burma Council named 19 June 'Burmese Mothers Day' to honour Burmese women whose children sacrificed their lives to restore democracy and peace in Burma. Burmese organizations in Australia celebrated the event with dinners and luncheons and called on Burmese organizations around the world to recognize June 19 as Burmese Mothers Day.

# **TOKYO & KOBE PROTESTS**

On the occasion of Daw Aung San Suu Kyi's birthday, activists from Japan, Burma, North America, Europe and New Zealand collected signatures in Kobe on 18 June for a giant birthday card and forwarded the fifth batch of letters to SLORC. The Burmese Relief Center (Japan) has to date received over 1,170 letters from 55 countries calling for her release. On 19 June, over 40 people donated blood in Tokyo to remember those who sacrificed their lives for freedom, democracy and human rights in Burma. The events were co-ordinated by the BRC-J, the Burma Youth Volunteer Association, and the International Network for Burma Relief.

# DANISH BURMA COMMITTEE

The Danish Burma Committee hosted Maung Maung, Federation of Trade Unions of Burma, Amanda Zappia, Australia Burma Council, and Harn Yawnghwe, ADDB, from 1-4 June in Copenhagen. The Burmese delegation briefed the Danish Ministry of Foreign Affairs, officials of the ruling Social Democratic Party, members of parliament and the Danish Burma Committee on the situation in Burma.

# MASSACHUSETTS ROUNDTABLE

Franklin Research & Development Corporation hosted a Massachusetts Burma Roundtable on 14 June. The meeting featured a video of a recent 'Rights & Wrongs' program which included several eye-witness accounts of human rights violations in the gas pipeline area in Burma.
